1. All Members must be over the age of eighteen (18), not a bankrupt and have not been convicted of an indictable offence in the past ten (10) years.
2. Membership Applications will not be considered unless they are accompanied by a completed Membership Questionnaire and payment of the applicable Membership Application Fee and Joining Fee. All payments must be received in full and approved by the AMA Treasurer.
3. All fees are non-refundable, except where an application for membership is declined by AMA or where written applications to the Management Committee to be assessed on a case-by-case basis.
4. Payments to AMA can be made by way of cheque or by electronic funds transfer into the following AMA bank account: Account Name: Australian Mung Bean Association Inc, BSB: 084-630, Account Number: 62-018-0663.
5. Membership Application Fees are payable by each Applicant. All Membership Fees are due and payable in advance of the Member's renewal date each year (being, 31 August).

6. Joining Fees are calculated on a monthly pro-rata basis following the 31st August. Joining Fees are payable regardless of whether the Applicant has previously been a member of the AMA.
7. If the Applicant is approved by the AMA Management Committee for membership, the Membership Application will go to the next General Meeting for ratification by the membership body. The Applicant will be informed whether their membership with AMA is ratified by announcement at the applicable General Meeting or by email from the AMA Secretary following the announcement.
8. If a Member breaches the Constitution of AMA or other membership terms and conditions, then their membership may be suspended or terminated in accordance with the AMA Constitution.
9. If a Member does not pay their Membership Fees, their membership will lapse and they will not have access to AMA's membership benefits. If a membership does lapse or is resigned, then that Member must not use any AMA trademarks or certifications or claim to be an AMA Member.
